

2020 United Way \$100K Payday TERMS AND CONDITIONS

All ticket holders understand and agree to the terms and conditions of the United Way \$100K Payday raffle for the benefit of United Way of Southeast Mississippi set forth herein:

- A ticket represents a chance to win the opportunity to accept an offer of the stated prize as per the terms and conditions set forth herein and in the Winner Notification Agreement.
- The purchase of a raffle ticket constitutes full agreement by the purchaser to all terms and conditions set forth herein and in the Winner Notification Agreement.
- No one will be eligible to win who procures a ticket through a check returned for “insufficient funds” or through charge to a debit or credit card that is “declined”, “invalid”, or “stolen”.
- Mailed application forms must be postmarked by Saturday, March 7, 2020; faxed and phone orders must be received by 4 p.m. on Friday, March 6, 2020; and online orders must be received by 5 p.m. on Sunday, March 8, 2020, to be eligible for the drawing. United Way of Southeast Mississippi is not responsible for applications lost in the mail.
- A maximum of 3,000 tickets will be sold. If less than 1,500 tickets have been sold by 5 p.m. on Sunday, March 8, 2020, the raffle will be cancelled, and each ticket holder will be refunded their \$100.00 purchase price.
- If purchaser(s) buys 3 tickets and all tickets are under the same name or combination of names, they receive one (1) free ticket that also must be under the same name or combination of names. One free ticket is given for any additional three that are purchased (i.e. if six (6) tickets are bought, purchaser(s) receive two (2) free tickets.)
- All tickets purchased by 11:59 p.m. on Sunday, February 2, 2020, will be entered into an Early Bird Prize Drawing with the winner of the Early Bird Prize Drawing winning a \$1,000 gift card to Carnival Cruise Lines. The drawing will be on February 18, 2020 at the United Way of Southeast Mississippi office. The winner will be contacted directly.
- United Way of Southeast Mississippi reserves the right to conduct additional drawings throughout the raffle. All Early Bird and additional raffle winners will remain eligible for the 100k raffle to be held on Monday, March 16, 2020. The
- After the raffle ticket drawing winner is selected on March 16, 2020, the United Way of Southeast Mississippi will forward the winner a Winner Notification Agreement, to be sent via certified, return receipt U.S. Mail. The winner will have ten (10) calendar days from the date of the winner’s receipt of the Winner Notification Agreement to accept the cash prize in the amount of \$100,000.00 (less applicable taxes) by executing and returning to United Way of Southeast Mississippi the signed Winner Notification Agreement pursuant to the terms and conditions stated therein. Upon

receipt of the Winner Notification Agreement, the cash prize of \$100,000.00 (less applicable taxes) will be tendered to the winner within thirty (30) calendar days from the date of the winner's acceptance of the cash prize as evidenced by the execution of the Winner Notification Agreement. If the executed Winner Notification Agreement is not received by United Way of Southeast Mississippi within said period, the prize will be automatically forfeited by the drawing winner.
